※ With the consent of the thesis advisor, students can count at most one course that is not offered by the finance department in the graduation credits. ※ The first rule does not restrict Foreign Students and Students who take the Finance-English program, but the courses can only be counted in the graduation credits with the consent of the department committee. ※ Master students shall not take less than 6 credits each semester in the first year of the master's degree.		
Finance-English Program: Students who have completed 5 of the following courses are qualified to apply for the Certificate of Finance-English Program. - At least 4 EMI courses offered by the department, including Financial Management, Investment Management, Financial Markets and Institutions, Option Market, Investment Banking, International Investment, Alternative Investment, etc. Course that are not listed above should be approved by the department committee. - Courses offered by the Language Center.		

Foreign Language Ability Requirement:

- a. The student can apply for a degree test only after obtaining the foreign language proficiency certificate.
- b. Master students must pass one of the following tests and hold a certificate to fulfill the graduation requirement.
 1. TOEFL paper test (TOEFL ITP) 527 points or above, or TOEFL computer-based test (TOEFL-CBT) 197 points or above, or TOEFL-iBT 71 points or above.
 2. General English Proficiency Test (GEPT) intermediate level or advanced level.
 3. TOEIC 750 points or more
 4. IELTS 5.5 points or above.
 5. Foreign Language Proficiency Test (FLPT), 240 points or above for the three English written tests.
 6. **Linguaskill CEFR B2 or above**
 7. Cambridge Main Suite, First Certificate in English (FCE) or above.
 8. **BESTEP Listening, Speaking, Reading, Writing CEFR B2 or above.**
 9. College Student English Proficiency Test (CSEPT) Level 2, 330 points or above
 10. Fulfilling the following two requirements: **(i)** Pass at least 1 intermediate-level course offered by the Language Center OR the EMI course offered by Prof. Yuhui Chen in the Department of Business Administration, **AND (ii)** pass at least 2 courses listed in the Finance-English Program. These courses that are counted to fulfill the foreign language ability requirement CANNOT be counted in the graduation credits.

Academic Ethics Education Course:

Students can apply for a degree test only after passing all the online core modules of the academic ethics courses offered by the Center for Taiwan Academic Research Ethics Education (<https://ethics.moe.edu.tw/>).
